I recognize that snowboarding entails serious risks. I relinquish all rights to an appeal for bodily and material damages, regardless of the cause, against the Alberta Snowboarding Association, its officers, employees, assignees, agents, representatives, and sponsors and any ski area in which the member may be attending or participating even if such damages results from negligence of the Alberta Snowboarding Association, its officers, employees, assignees, agents, representatives, and sponsors.

Without restricting the generality of the preceding, I also relinquish the right to appeal against the Alberta Snowboarding Association, its officers, employees, assignees, agents, representatives, and sponsors and any ski area in which the member may be attending or participating resulting from a decision on their part, regardless of the nature of this decision.

### **Alberta Snowboarding Association Member Code of Conduct**

ASA members of all ages are role models and as such are expected to exhibit exemplary behavior and good sportsmanship at training, competitions, and when traveling. Every member of the Alberta Snowboarding Association must adhere to the following Code of Conduct while at or participating in ASA sanctioned, sponsored events, or training sessions:

- 1) Refrain from becoming, giving the appearance, or being intoxicated.
- 2) Refrain from threatening, abusive, coarse, and/or rude language and behavior.
- 3) Speak to others in a constructive manner and make any appeals through the proper channels only.
- 4) Recognize the need for safety and refrain from any reckless activity.
- 5) Respect other persons, public and private property, and the rules, regulations, or norms of conduct of public occasions.
- 6) Refrain from possessing or using illegal substances.

Every member shall recognize that he/she is viewed as being a representative of Alberta and the Alberta Snowboarding Association, even when not acting in any official capacity, and shall govern themselves accordingly at all times.

Every athlete acknowledges that any breach in the Alberta Snowboarding Association Member Code of Conduct may result in disciplinary action, up to and including expulsion from the ASA.
